PRELIMINARY INJUNCTION ORDER

THIS CAUSE being before the Court on Plaintiff, HYDRAFLOW INDUSTRIES LIMITED ("HYDRAFLOW" or "Plaintiff"), Motion for a Preliminary Injunction, and this Court having heard the evidence before it hereby GRANTS Plaintiff's Motion for Entry of a Preliminary Injunction in its entirety against the defendants identified in Schedule A (collectively, the "Defendants").

THIS COURT HEREBY FINDS that it has personal jurisdiction over the Defendants since the Defendants directly target their business activities toward consumers in the United States, including Illinois. "In the context of cases like this one, that means a plaintiff must show that each defendant is actually operating an interactive website that is accessible in Illinois and that each defendant has aimed such site at Illinois by standing ready, willing and able to ship its counterfeit goods to customers in Illinois in particular (or otherwise has some sufficient voluntary contacts with the state)." *Am. Bridal & Prom Indus. Ass'n v. P'ships & Unincorporated Ass'ns Identified on Schedule A*, 192 F.Supp.3d 924, 934 (N.D. Ill. 2016). In this case, Plaintiff has presented screenshot evidence that each Defendant Internet Store is reaching out to do business with Illinois

residents can and do purchase products using counterfeit versions of Plaintiff's Trademarks. *See* Docket No. 13 which includes screenshot evidence confirming that each Defendant Internet Store does stand ready, willing and able to ship its counterfeit goods to customers in Illinois bearing infringing and/or counterfeit versions of the SUSHEZI Trademark No. 3,598,997 (the "SUSHEZI Trademark") and Plaintiff's SUSHEZI Copyright Registration No. VA0002196865 (the "SUSHEZI Work").

THIS COURT FURTHER FINDS that injunctive relief previously granted in the Temporary Restraining Order ("TRO") should remain in place through the pendency of this litigation and that issuing this Preliminary Injunction is warranted under Federal Rule of Civil Procedure 65. Evidence submitted in support of this Motion and in support of HYDRAFLOW's previously granted Motion for a Temporary Restraining Order establishes that HYDRAFLOW has a likelihood of success on the merits; that no remedy at law exists; and that HYDRAFLOW will suffer irreparable harm if the injunction is not granted.

Specifically, HYDRAFLOW has proved a *prima facie* case of trademark infringement because (1) the SUSHEZI Trademark is a distinctive mark and registered with the U.S. Patent and Trademark Office on the Principal Register and the SUSHEZI Work is registered with the United States Copyright Office, (2) Defendants are not licensed or authorized to use any of the SUSHEZI Trademark and SUSHEZI Work, and (3) Defendants' use of the SUSHEZI Trademark and SUSHEZI Work is causing a likelihood of confusion as to the origin or sponsorship of Defendants' products with HYDRAFLOW. Furthermore, Defendants' continued and unauthorized use of the SUSHEZI Trademark and SUSHEZI Work irreparably harms HYDRAFLOW through diminished goodwill and brand confidence, damage to HYDRAFLOW's reputation, loss of exclusivity, and loss of future sales. Monetary damages fail to address such damage and,

therefore, HYDRAFLOW has an inadequate remedy at law. Moreover, the public interest is served by entry of this Preliminary Injunction to dispel the public confusion created by Defendants' actions. Accordingly, this Court orders that:

- 1. Defendants, their affiliates, officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under or in active concert with them be temporarily enjoined and restrained from:
 - a. using HYDRAFLOW' SUSHEZI or any reproductions, counterfeit copies or colorable imitations thereof in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine SUSHEZI product or not authorized by HYDRAFLOW to be sold in connection with HYDRAFLOW's SUSHEZI Trademark and SUSHEZI Work;
 - b. passing off, inducing, or enabling others to sell or pass off any product as a genuine SUSHEZI product or any other product produced by HYDRAFLOW, that is not HYDRAFLOW's or not produced under the authorization, control or supervision of HYDRAFLOW and approved by HYDRAFLOW for sale under HYDRAFLOW's SUSHEZI Trademark and SUSHEZI Work;
 - c. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control or supervision of HYDRAFLOW, or are sponsored by, approved by, or otherwise connected with HYDRAFLOW;
 - d. further infringing HYDRAFLOW's SUSHEZI Trademark and SUSHEZI
 Work and damaging HYDRAFLOW 's goodwill;
 - e. otherwise competing unfairly with HYDRAFLOW in any manner;

- f. shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for HYDRAFLOW, nor authorized by HYDRAFLOW to be sold or offered for sale, and which bear any of HYDRAFLOW's SUSHEZI Trademark and SUSHEZI Work or any reproductions, counterfeit copies or colorable imitations thereof;
- g. using, linking to, transferring, selling, exercising control over, or otherwise owning the Online Marketplace Accounts, or any other online marketplace account that is being used to sell or is the means by which Defendants could continue to sell Counterfeit/Infringing SUSHEZI Products; and
- h. operating and/or hosting websites registered or operated by Defendants that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product bearing HYDRAFLOW's SUSHEZI Trademark and SUSHEZI Work or any reproductions, counterfeit copies or colorable imitations thereof that is not a genuine SUSHEZI product or not authorized by HYDRAFLOW to be sold in connection with HYDRAFLOW's SUSHEZI Trademark and SUSHEZI Trademark and SUSHEZI Work.
- 4. Those in privity with Defendants and with actual notice of this Order, including any online marketplaces such as, but not limited to, Amazon Payments Inc., Alibaba Group Holding Ltd. along with any related Alibaba entities (collectively, "Alibaba"), social media platforms, Facebook, YouTube, LinkedIn, Twitter, Internet search engines such as Google, Bing and Yahoo, shall within two (2) business days of receipt of this Order:

- a. disable and cease providing services for any accounts through which Defendants engage in the sale of counterfeit and infringing goods using the SUSHEZI Trademark and SUSHEZI Work, including any accounts associated with the Defendants listed in Schedule A;
- b. disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using the SUSHEZI Trademark and SUSHEZI Work; and
- c. take all steps necessary to prevent links to the Defendant Online Marketplace Accounts identified in Schedule A from displaying in search results, including, but not limited to, removing links to the Online Marketplace Accounts from any search index.
- 5. Defendants and any third party with actual notice of this Order who is providing services for any of the Defendants, or in connection with any of Defendants' Online Marketplace Accounts or other websites operated by Defendants, including, without limitation, any online marketplace platforms such as, but not limited to, Alibaba, advertisers, Facebook, Internet Service Providers ("ISP"), web hosts, back-end service providers, web designers, sponsored search engine or ad-word providers, banks, merchant account providers, including, but not limited to, PayPal, Amazon, Alibaba, Western Union, third party processors and other payment processing service providers, and shippers (collectively, the "Third Party Providers") shall, within five (5) business days after receipt of such notice, provide to HYDRAFLOW expedited discovery, including copies of all documents and records in such person's or entity's possession or control relating to:

- a. The identities and locations of Defendants, their agents, servants, employees, confederates, attorneys, and any persons acting in concert or participation with them, including all known contact information;
- b. the nature of Defendants' operations and all associated sales and financial information, including, without limitation, identifying information associated with the Online Marketplace Accounts, and Defendants' financial accounts, as well as providing a full accounting of Defendants' sales and listing history related to their respective Online Marketplace Accounts;
- c. Defendants' websites and/or any Online Marketplace Accounts;
- d. The Defendant Online Marketplace Accounts registered by Defendants; and
- e. Any financial accounts owned or controlled by Defendants, including their agents, servants, employees, confederates, attorneys, and any persons acting in concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, but not limited to and without limitation, Amazon, PayPal, Alipay, Alibaba, Western Union, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).
- 6. Defendants and any persons in active concert or participation with them who have actual notice of this Order shall be temporarily restrained and enjoined from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.

- 7. Western Union shall, within two (2) business days of receipt of this Order, block any Western Union money transfers and funds from being received by the Defendants identified in Schedule A until further ordered by this Court.
- 8. eBay, Inc. ("eBay"), PayPal, Inc. ("PayPal"), ContextLogic, Inc. ("WISH"), Amazon Payments, Inc. ("Amazon"), Alipay US, Inc. and its entities ("Alipay"), Alibaba Group Holding Limited ("Alibaba") and Heguang International Limited or Dunhuang Group d/b/a DHGATE, DHGate.com, DHPORT, DHLINK and DHPAY ("DHGate"), shall, within three (3) business days of receipt of this Order, for any Defendant or any of Defendants' Online Marketplace Accounts or websites:
 - a. Locate all accounts and funds connected to Defendants, Defendants' Online Marketplace Accounts or Defendants' websites, including, but not limited to, any eBay, PayPal, WISH, Amazon, Alipay, Alibaba and DHGate accounts, connected to the information listed in Schedule A hereto or the email addresses identified in Exhibit 3 to the Declaration of Kevin Anderson; and
 - b. Restrain and enjoin any such accounts or funds that are non-U.S. foreign based from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 9. Any banks, savings and loan associations, payment processors, or other financial institutions, for any Defendant or any of Defendants' Online Marketplace Accounts or websites, shall within two (2) business days of receipt of this Order:

a. Locate all accounts and funds connected to Defendants, or Defendants' Online Marketplace Accounts, including, but not limited to, any accounts

connected to the information listed in Schedule A hereto or the email addresses identified in Exhibit 3 to the Declaration of Kevin Anderson; and

b. Restrain and enjoin such accounts from receiving, transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.

10. HYDRAFLOW may provide notice of these proceedings to Defendants, including notice of the preliminary injunction hearing and service of process pursuant to Fed.R.Civ.P. 4(f)(3), by electronically publishing a link to the Complaint, this Order and other relevant documents on a website, or by sending an e-mail to the e-mail addresses identified in Exhibit 3 to the Declaration of Kevin Anderson and any e-mail addresses provided for Defendants by third parties that includes a link to said website. The Clerk of Court is directed to issue a single original summons in the name of "Doublewings (Xiamen) Import & Export Co., Ltd. and all other Defendants identified in Complaint" that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from Online Marketplace Accounts and payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.

- 11. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order on two days' notice to HYDRAFLOW or on shorter notice as set by this Court.
- 12. The \$10,000 bond posted by HYDRAFLOW shall remain with the Court until a Final disposition of this case or until this Preliminary Injunction is terminated.
