SEALED TEMPORARY RESTRAINING ORDER

THIS CAUSE being before the Court on Plaintiff ART ASK AGENCY, *Ex Parte* Motion for Entry of a Temporary Restraining Order, including a Temporary Injunction, a Temporary Transfer of the Defendant Domain Names, a Temporary Asset Restraint, Expedited Discovery, and Service of Process by Email and Electronic Publication (the "Ex Parte Motion") against the defendants identified on Schedule A to the Complaint and attached hereto (collectively, the "Defendants") and using at least the domain names identified in Schedule A (the "Defendant Domain Names") and the online marketplace accounts identified in Schedule A (the "Online Marketplace Accounts"), and this Court having heard the evidence before it hereby GRANTS Plaintiffs' Ex Parte Motion as follows.

This Court further finds, in the absence of adversarial presentation, that it has personal jurisdiction over the Defendants because the Defendants directly target their business activities toward consumers in the United States, including Illinois. Specifically, Defendants have targeted sales to Illinois residents by setting up and operating e-commerce stores that target United States consumers, offer shipping to the United States, including Illinois, and accept payment in U.S.

dollars, and have sold products using infringing and counterfeit versions of the Anne Stokes mark and of U.S. Copyright Registration Nos. VA 2-152-019 for Spell Weaver, VA 2-152-045 for Dark Hearts, VA 2-152-048 for Protector, VA 2-152-055 for Gothic Prayer, VA 2-152-057 for Blue Moon, VA 2-152-058 for Dragonkin, VA 2-152-061 for Spirit Guide, VA 2-152-063 for Kindred Spirits, VA 2-152-064 for Angel Rose, VA 2-152-065 for Summon the Reaper, VA 2-152-067 for Aracnafaria and VA 2-152-068 for Enchantment for ANNE STOKES, to residents of Illinois.

This Court also finds that issuing this Order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate because Plaintiff has presented specific facts in the Declaration of Maria Strid and the Declaration of Michael A. Hierl in support of the Motion for Temporary Restraining Order and accompanying evidence clearly showing that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition. Specifically, in the absence of an *ex parte* Order, Defendants could and likely would move any assets from accounts in financial institutions under this Court's jurisdiction to offshore accounts. Accordingly, this Court orders that:

- 1. Defendants, their affiliates, officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under, or in active concert with them be temporarily enjoined and restrained from:
 - a. using Plaintiff's ANNE STOKES trademark and ANNE STOKES Copyrights or any reproductions, counterfeit copies or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any products that are not genuine ANNE

- STOKES products or not authorized by Plaintiff to be sold in connection with Plaintiff's ANNE STOKES trademark and ANNE STOKES Copyrights;
- b. passing off, inducing, or enabling others to sell or pass off any products as genuine ANNE STOKES products or any other product produced by Plaintiff, that is not Plaintiff's or not produced under the authorization, control, or supervision of Plaintiff and approved by Plaintiff for sale under Plaintiff's ANNE STOKES trademark and/or ANNE STOKES Copyrights;
- c. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control, or supervision of Plaintiff, or are sponsored by, approved by, or otherwise connected with Plaintiff;
- d. further infringing Plaintiff's ANNE STOKES trademark and ANNE STOKES Copyrights and damaging Plaintiff's goodwill; and
- e. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Plaintiff, nor authorized by Plaintiff to be sold or offered for sale, and which bear any of Plaintiff's ANNE STOKES trademark and/or ANNE STOKES Copyrights or any reproductions, counterfeit copies or colorable imitations.
- 2. The domain name registries for the Defendant Domain Names, including, but not limited to, VeriSign, Inc., Neustar, Inc., Afilias Limited, CentralNic, Nominet, and the Public Interest Registry, and the domain name registrars, including, but not limited to, GoDaddy Operating Company LLC, Name.com, PDR LTD. d/b/a

PublicDomainRegistry.com, and Namecheap Inc., within three (3) business days of receipt of this Order or prior to expiration of this Order, whichever date shall occur first, shall disable Defendants' Domain Names and make them inactive and untransferable until further order by this Court.

- 3. Upon Plaintiff's request, any third party with actual notice of this Order who is providing services for any of the Defendants, or in connection with any of Defendants' websites at the Defendant Domain Names or other websites operated by Defendants, including, without limitation, any online marketplace platforms such as iOffer and Alibaba (collectively, the "Third Party Providers") shall, within five (5) business days after receipt of such notice, provide to Plaintiff expedited discovery, including copies of all documents and records in such person's or entity's possession or control sufficient to determine:
 - a. the identities and locations of Defendants, their agents, servants, employees, confederates, attorneys, and any persons acting in concert or participation with them, including all known contact information and all associated e-mail addresses;
 - b. the nature of Defendants' operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplace Accounts, the Defendant Domain Names, and Defendants' financial accounts, including Defendants' sales and listing history related to their respective Online Marketplace Accounts and Defendant Domain Names; and
 - c. any financial accounts owned or controlled by Defendants, including their agents, servants, employees, confederates, attorneys, and any persons acting in

concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, Amazon, eBay, PayPal, DHgate, Western Union, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).

- 4. Upon Plaintiff's request, those with notice of the injunction, including Third Party Providers, shall, within three (3) business days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using the ANNE STOKES trademark and ANNE STOKES Copyrights.
- 5. Defendants shall be temporarily restrained and enjoined from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
- 6. Any Third Party Providers, including eBay, DHgate, PayPal, and Amazon shall, within two (2) business days of receipt of this Order:
 - a. locate all accounts and funds of Defendants, Defendants' Online Marketplace

 Accounts or Defendants' websites, including, but not limited to, any accounts

 connected to and related to the information listed in Schedule A to the

 Complaint; and
 - b. restrain and enjoin any such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
 - 7. Plaintiff may provide notice of these proceedings to Defendants, including notice

of the preliminary injunction hearing, service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Complaint, this Order, and other relevant documents on a website and by sending an e-mail to the e-mail addresses identified in Schedule A to the Complaint and any e-mail addresses provided for Defendants by third parties that includes a link to said website. The Clerk of the Court is directed to issue a single original summons in the name of "find athena and all other Defendants identified in the Complaint" that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.

- 8. Plaintiff's Complaint, Schedule A to the Complaint, Exhibit 2 to the Declaration of Maria Strid, and this Order shall remain sealed until further order by this Court.
- 9. Within three (3) business days of entry of this Order, Plaintiff shall deposit with the Court Ten Thousand Dollars (\$10,000.00), either cash or surety bond, as security, which amount has, in the absence of adversarial testing, been deemed adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.
- 10. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order as permitted by and in compliance with the Federal Rules of Civil Procedure and the Northern District of Illinois Local Rules.

This Temporary Restraining Order without notice is entered on August 5, 2020 at 2:30 P.M. and shall remain in effect for fourteen (14) days.
