REQUEST FOR CLERK'S ENTRY OF DEFAULT

Plaintiffs, Whirlpool Corporation, Whirlpool Properties, Inc., and Maytag Properties, LLC ("Plaintiffs"), by and through their undersigned counsel, hereby request that the Clerk enter default in this matter against Defendants¹, the Individuals, Partnerships and Unincorporated Associations as identified on Schedule "A" hereto (collectively "Defendants") on the ground that Defendants have failed to appear or otherwise respond to the Complaint within the time prescribed by the Federal Rules of Civil Procedure. (Declaration of Stephen M. Gaffigan in Support of Plaintiffs' Request for Clerk's Entry of Default ("Gaffigan Decl.") ¶ 6, filed concurrently herewith.)

On October 30, 2020, Defendants were served with respective Summons and copies of the Complaint and Amended Complaint via electronic mail ("e-mail") and via website posting pursuant to the Court's Order authorizing alternate service of process. (Gaffigan Decl. ¶ 3; see ECF No. 22-1 and 22-2, Affidavits of Service on file with the Court.)

Time allowed for Defendants to respond to the Complaint has expired. (<u>Id.</u> at ¶ 4.) Neither Plaintiffs nor the Court has granted the Defendants an extension of time to respond to the Complaint. (<u>Id.</u> at ¶ 5.) Defendants have failed to answer or otherwise respond to the Complaint, or serve a copy of any Answer or other response upon Plaintiffs' attorneys of record. (<u>Id.</u> at ¶ 6.) Plaintiffs are informed and believe that Defendants are not infants or incompetent person. (<u>Id.</u> at ¶ 7.) Plaintiffs are informed and believe that the Servicemembers Civil Relief Act does not apply. (<u>Id.</u>)

WHEREFORE, Plaintiffs, Whirlpool Corporation, Whirlpool Properties, Inc., and Maytag Properties, LLC, request that default be entered against Defendants, the Individuals, Partnerships and Unincorporated Associations as identified on Schedule "A" hereto (collectively "Defendants").
