SEALED TEMPORARY RESTRAINING ORDER

On this day, the Court considered Plaintiff's *Ex Parte* Motion for the following: (1) a temporary injunction against the individuals, corporations, limited liability companies, partnerships, and unincorporated associations and foreign entities identified on Schedule A to the Complaint and attached hereto (collectively, "Defendants"), enjoining the marketing, advertising, offering for sale, and sale of counterfeit TANGLE products ("Counterfeit Products") bearing, using, or infringing upon Plaintiff's trademark, which is covered by U.S. Trademark Registration No. 1779055 ("the "TANGLE Trademark"), and copyrights, which are covered by at least U.S. Copyright Office Registration Nos. VA 120-368, VA 1-232-933, VA 1-271-045, VAu 35-392, VAu 35-391, VAu 35-390, VAu 35-389, VAu 35-388, and VAu 35-387 (collectively, the "TANGLE Copyright Registrations"); (2) a temporary transfer of Defendants' online marketplace websites (hereinafter the "Defendant Internet Stores," also identified on Schedule A to the Complaint), to Plaintiff; (3) a temporary restraint of Defendants' assets to preserve Plaintiff's right to an equitable accounting; (4) expedited discovery allowing Plaintiff to inspect and copy Defendants' records relating to the

manufacture, distribution, offering for sale, and sale of Counterfeit Products and Defendants' financial accounts; and (5) service by e-mail and/or electronic publication (collectively, the "Ex Parte Motion for TRO").

Having reviewed the papers submitted, and being fully advised, the Court hereby GRANTS Plaintiff's Motion as follows:

This Court finds, in the absence of adversarial presentation, that it has personal jurisdiction over Defendants because Defendants directly target their business activities toward consumers in the United States, including Illinois, offering to sell and ship products into this Judicial District. Specifically, Defendants are reaching out to do business with Illinois residents by operating one or more commercial, fully interactive internet stores through which Illinois residents can purchase Counterfeit Products bearing, using, or infringing upon Plaintiff's trademark, covered by U.S. Trademark Registration No. 1779055, and copyrights, which are covered by at least U.S. Copyright Office Registration Nos. VA 120-368, VA 1-232-933, VA 1-271-045, VAu 35-392, VAu 35-391, VAu 35-390, VAu 35-389, VAu 35-388, and VAu 35-387. Defendants have offered for sale and sold unauthorized Counterfeit Products bearing, using, or infringing on the TANGLE Trademark and TANGLE Copyright Registrations through accounts with online marketplace platforms including Alibaba.com, AliExpress.com, Amazon.com, DHgate.com, eBay.com, JD.com, Joom.com, Walmart.com, and Wish.com (the "Marketplace Platforms") held by Defendants (the "User Accounts").

This Court also finds that issuing this Order without notice pursuant to Fed. R. Civ. P. 65(b)(1) is appropriate because Plaintiff has presented specific facts in the Declarations of Richard Zawitz and David Hutchinson, and accompanying evidence clearly showing that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition.

Specifically, in the absence of an *ex parte* Order, Defendants could and likely would modify registration data and content, change hosts, redirect traffic to other websites in their control, and move any assets from accounts in U.S.-based financial institutions to offshore accounts.

The Court finds that Plaintiff has shown (a) Plaintiff have a reasonable likelihood of success on the merits, (b) no adequate remedy at law exists, (c) Plaintiff will suffer irreparable harm without injunctive relief, (d) the irreparable harm suffered without injunctive relief outweighs the irreparable harm Defendants will suffer if the injunction is granted, and (e) the injunction will not harm the public interest.

Effective immediately, the Court further ORDERS as follows:

Temporary Injunction Enjoining the Advertising, Offering for Sale, and Sale of Counterfeit Products

- 1. Defendants, their affiliates, officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under, or in active concert with them are temporarily enjoined and restrained from:
 - a. using the TANGLE Trademark or TANGLE Copyright Registrations or any reproductions, counterfeit copies, or colorable imitations in any manner substantially identical or confusingly similar to Plaintiff's copyrights in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine TANGLE Product or is not authorized by Plaintiff to be sold in connection with the TANGLE Trademark of TANGLE Copyright Registrations;
 - b. passing off, inducing, or enabling others to sell or pass off any product as a genuine TANGLE Product that is not, in fact, any of Plaintiff's genuine TANGLE Products and/or not produced under the authorization, control, or

- supervision of Plaintiff and approved by Plaintiff for sale in connection with the TANGLE Trademark or TANGLE Copyright Registrations;
- c. committing any acts calculated to cause consumers to believe that

 Defendants' Counterfeit Products are those sold under the authorization,
 control, or supervision of Plaintiff, or are sponsored by, approved by, or
 otherwise connected with Plaintiff;
- d. further infringing the TANGLE Trademark or TANGLE Copyright
 Registrations and damaging Plaintiff's goodwill;
- e. otherwise competing unfairly with Plaintiff in any manner;
- f. manufacturing, shipping, delivering, holding for sale, transferring, or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Plaintiff, nor authorized by Plaintiff to be sold or offered for sale, which is distributed, marketed, advertised, offered for sale, and which infringe any of Plaintiff's federally registered intellectual property, including the TANGLE Trademark and TANGLE Copyright Registrations, or any reproductions, counterfeit copies, or colorable imitations;
- g. using, linking to, transferring, selling, exercising control over, or otherwise owning the User Accounts, the Defendant Internet Stores, or any other domain name or online marketplace account that is being used to sell or is the means by which Defendants could continue to sell Counterfeit Products; and
- h. operating and/or hosting websites and/or other online presence registered

or operated by Defendants that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product incorporating the TANGLE Trademark or TANGLE Copyright Registrations.

Temporary Transfer of Defendant Internet Stores

- 2. Within five (5) days of receipt of this Order the Marketplace Platforms shall:
 - a. disable and cease providing services for any User Accounts through which
 Defendants engage in the sale of Counterfeit Products, including any User
 Accounts associated with the Defendants listed on Schedule A to the Complaint;
 - b. disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of Counterfeit Products; and
 - c. take all steps necessary to prevent links to the Defendant Internet Stores identified on Schedule A from displaying in search results, including, but not limited to, removing links to the Defendant Internet Stores from any search index.

Temporary Asset Restraint

- 3. Pursuant to Fed. R. Civ. P. 64 and 65, and this Court's inherent equitable power to issue provisional remedies ancillary to its authority to provide final equitable relief, as sufficient cause has been shown, Defendants and any persons in active concert or participation with them who have actual notice of this Order shall be temporarily restrained and enjoined from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 4. Within five (5) days of receipt of service of this Order, (i) Contextlogic, Inc. ("Wish"), (ii) PayPal, Inc. ("PayPal"), (iii) Payoneer, Inc. ("Payoneer"), (iv) the Alibaba Group d/b/a Alibaba.com and Aliexpress.com ("Alibaba"), (v) Amazon Payment Systems, Inc. and Amazon.com, Inc. ("Amazon"), (vi) Ping Pong Global Solutions, Inc. ("Ping Pong"), (vii) eBay,

Inc. ("eBay"), (viii) Coinbase Global, Inc. ("Coinbase"), (ix) LianLian Global t/as LL Pay U.S., LLC ("LianLian"), (x) GoAllPay ("AllPay"), (xi) Union Mobile Financial Technology Co., Ltd ("Union Mobile"), (xii) World First UK Ltd. ("World First"), (xiii) Paxful, Inc. ("Paxful"), (xiv) Stripe, Inc. ("Stripe"); and (xv) other payment processing service providers (collectively "Financial Institutions") shall:

- a. locate all accounts associated with Defendants (the "Defendants' Accounts")
 and other assets belonging to Defendants, including any cryptocurrency (the "Defendants' Assets"); and
- locate, attach, and restrain the transfer or disposing of monies or funds from
 Defendants' Accounts, as well as the transfer or disposing of Defendants'
 Assets, until further ordered by this Court.
- 5. The Financial Institutions shall provide written confirmation of their compliance with the foregoing to Plaintiff's counsel.

Expedited Discovery

- 6. As sufficient cause has been shown, within five (5) days of receipt of service of this Order, the Financial Institutions, including each of the Marketplace Platforms in their capacity as an online marketplace platform, as well as any domain name registries, shall provide the following information to Plaintiff's counsel (to the extent such information is in the Financial Institutions', Marketplace Platforms' and/or domain name registrars' possession, custody, or control):
 - a. Identifying information for Defendants, including all available contact information (which shall include all known e-mail addresses and mailing addresses), as well as account numbers and account balances;
 - b. Any User Accounts and/or online marketplace websites affiliated with

- Defendants that are not listed on Schedule A to the Complaint;
- c. Information concerning any of the Defendants' Accounts or Defendants' Assets, including any financial accounts affiliated with the Defendants via any means, without limitation, the Financial Institutions, as well as any other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and Visa).

Service by Electronic Mail and/or Electronic Publication

- 7. Pursuant to Fed. R. Civ. P. 4(f)(3), as sufficient cause has been shown, service of this Order and the Summons and Complaint may be made on, and shall be deemed effective as to Defendants if it is completed by either of the following means:
 - a. Delivery of: (i) PDF copies of this Order together with the Summons and Complaint; (ii) a link to a website where each Defendant will be able to download PDF copies of this Order together with the Summons and Complaint; and all papers filed in support of Plaintiff's application (the "Link") to Defendants' e-mail addresses as provided by the Financial Institutions and/or Marketplace Platforms; and
 - b. Requesting that the Financial Institutions and/or Marketplace Platforms cause

 Defendants' online marketplace website(s) to redirect to the Link.
- 8. Such alternative service by electronic means ordered herein shall be made within five (5) days of the Financial Institutions compliance with Paragraphs 4 through 6 of this Order.
- 9. The Clerk of Court is directed to issue a single original summons in the name of "THE INDIVIDUALS, CORPORATIONS, LIMITED LIABILITY COMPANIES, PARTNERSHIPS, AND UNINCORPORATED ASSOCIATIONS IDENTIFIED ON SCHEDULE A HERETO" that

shall apply to all Defendants.

10. The combination of providing notice via electronic publication or e-mail, along with any notice that Defendants receive from domain name registrars and payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.

Security Bond

11. Plaintiff shall deposit with the Court Five Thousand Dollars (\$5,000.00), either cash, cashier's check or surety bond, as security, which amount was determined adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.

Sealing Order

- 12. Plaintiff's Schedule A to the Complaint and Exhibit 2 to the Declaration of Richard Zawitz shall remain sealed until Defendants' Accounts and Defendants' Assets are restrained.
- 13. Plaintiff shall file unsealed versions of Schedule A to the Complaint (Dkt. No. 4) and Exhibit 2 to the Declaration of Richard Zawitz (Dkt. No. 17) using the CM/ECF system prior to the expiration of this Order.

Application to Vacate or Dissolve

14. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order on two (2) days' notice to Plaintiff or on shorter notice as set by this Court.

IT IS FURTHER ORDERED that a hearing shall be held on May 19, 2022, at 9:45 a.m. via teleconference, during which Plaintiff may present its motion for a preliminary injunction, or alternatively, any motion to extend this Temporary Restraining Order.

This Temporary Restraining Order without notice is entered at 4:45 p.m. on May 5, 2022

and shall remain in effect for fourteen (14) days.
