PRELIMINARY INJUNCTION ORDER

Plaintiff Entertainment One UK Ltd. ("E-ONE") filed a Motion for Entry of a Preliminary Injunction against the against the fully interactive, e-commerce stores operating under the seller aliases identified in Schedule A to the Complaint and attached hereto (collectively, "Defendants") and using at least the online marketplace accounts identified in Schedule A (the "Online Marketplaces"). After reviewing the Motion and the accompanying record, this Court GRANTS E-ONE's Motion in part as follows.

This Court finds E-ONE has provided notice to Defendants in accordance with the Temporary Restraining Order entered July 1, 2022, ECF No. 21 ("TRO"), and Federal Rule of Civil Procedure 65(a)(1).

This Court also finds, in the absence of adversarial presentation, that E-ONE has provided a basis to conclude that Defendants have sold products bearing unauthorized copies of E-ONE's federally registered copyrights (the "PEPPA PIG Copyrights") and/or using infringing and counterfeit versions of E-ONE's federally registered trademarks (the "PEPPA PIG Trademarks").

This Court also finds that the injunctive relief previously granted in the TRO should remain in place through the pendency of this litigation and that issuing this Preliminary Injunction is warranted under Federal Rule of Civil Procedure 65. Evidence submitted in support of this Motion and in support of E-ONE's previously granted Motion for Entry of a TRO establishes that E-ONE has demonstrated a likelihood of success on the merits; that no remedy at law exists; and that E-ONE will suffer irreparable harm if the injunction is not granted.

Specifically, E-ONE has proved a *prima facie* case of trademark infringement because (1) the PEPPA PIG Trademarks are distinctive marks and are registered with the U.S. Patent and Trademark Office on the Principal Register, (2) Defendants are not licensed or authorized to use any of the PEPPA PIG Trademarks, and (3) Defendants' use of the PEPPA PIG Trademarks is causing a likelihood of confusion as to the origin or sponsorship of Defendants' products with E-ONE. E-ONE has also proved a prima facie case of copyright infringement because it has demonstrated that (1) E-ONE is the owner of valid and enforceable PEPPA PIG Copyrights, and (2) Defendants, without any authorization from E-ONE, or any right under the law, have deliberately copied, displayed, distributed, reproduced, and/or made derivate works incorporating the PEPPA PIG Copyrights. Furthermore, Defendants' continued and unauthorized use of the PEPPA PIG Trademarks and Copyrights irreparably harms E-ONE through diminished goodwill and brand confidence, damage to E-ONE's reputation, loss of exclusivity, and loss of future sales. Monetary damages fail to address such damage and, therefore, E-ONE has an inadequate remedy at law. Moreover, the public interest is served by entry of this Preliminary Injunction to dispel the public confusion created by Defendants' actions. Accordingly, this Court orders that:

- 1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be preliminarily enjoined and restrained from:
 - a. using the PEPPA PIG Trademarks or any reproductions, counterfeit copies, or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine E-ONE product or not authorized by E-ONE to be sold in connection with the PEPPA PIG Trademarks;
 - b. reproducing, distributing copies of, making derivative works of, or publicly displaying the PEPPA PIG Copyrights in any manner without the express authorization of E-ONE;
 - c. passing off, inducing, or enabling others to sell or pass off any product as a genuine E-ONE product or any other product produced by E-ONE, that is not E-ONE's or not produced under the authorization, control, or supervision of E-ONE and approved by E-ONE for sale under the PEPPA PIG Trademarks or Copyrights;
 - d. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control, or supervision of E-ONE, or are sponsored by, approved by, or otherwise connected with E-ONE; and
 - e. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for E-ONE, nor authorized by E-ONE to be sold or offered for sale, and which bear any of E-ONE's trademarks or copyrights, including the PEPPA PIG Trademarks, or any reproductions,

counterfeit copies, or colorable imitations thereof and/or which bear the PEPPA PIG Copyrights.

- 2. Defendants shall not transfer or dispose of any money or other of Defendants' assets in any of Defendants' financial accounts.
- 3. Upon E-ONE's request, Defendants and any third party with actual notice of this Order who is providing services for any of Defendants, or in connection with any of Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as eBay, Inc., AliExpress, Alibaba Group Holding Ltd. ("Alibaba"), Amazon.com, Inc., ContextLogic Inc. d/b/a Wish.com ("Wish.com"), and Dhgate (collectively, the "Third Party Providers"), shall, within seven (7) calendar days after receipt of such notice, provide to E-ONE expedited discovery, limited to copies of documents and records in such person's or entity's possession or control sufficient to determine:
 - a. the identities and locations of Defendants, their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses;
 - b. the nature of Defendants' operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplaces and Defendants' financial accounts, including Defendants' sales and listing history related to their respective Online Marketplaces; and
 - c. any financial accounts owned or controlled by Defendants, including their officers, agents, servants, employees, attorneys, and any persons acting in active concert or

participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, PayPal, Inc. ("PayPal"), Alipay, Wish.com, Alibaba, Ant Financial Services Group ("Ant Financial"), Amazon Pay, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).

- 4. Upon E-ONE's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 3, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using the PEPPA PIG Trademarks and/or which bear the PEPPA PIG Copyrights.
- 5. Any Third Party Providers, including PayPal, Alipay, Alibaba, Ant Financial, Wish.com, and Amazon Pay, shall, within seven (7) calendar days of receipt of this Order:
 - a. locate all accounts and funds connected to Defendants' seller aliases, including, but
 not limited to, any financial accounts connected to the information listed in
 Schedule A hereto, and any e-mail addresses provided for Defendants by third
 parties; and
 - b. restrain and enjoin any such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
- 6. E-ONE may provide notice of the proceedings in this case to Defendants, including service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Pleadings, this Order, and other relevant

documents on a website and by sending an e-mail with a link to said website to any e-

mail addresses provided for Defendants by third parties. The Clerk of the Court is

directed to issue a single original summons in the name of "Dingzhou Jiabeile Clothing

Ltd. and all other Defendants identified in the Operative Complaint" that shall apply to

all Defendants. The combination of providing notice via electronic publication and e-

mail, along with any notice that Defendants receive from payment processors, shall

constitute notice reasonably calculated under all circumstances to apprise Defendants

of the pendency of the action and afford them the opportunity to present their

objections.

7. Plaintiff's Schedule A to the Complaint (ECF No. 2), Exhibit 3 to the Declaration of

Niall Trainor (ECF No. 16), and the TRO (ECF No. 21) are unsealed.

8. Any Defendants that are subject to this Order may appear and move to dissolve or modify

the Order as permitted by and in compliance with the Federal Rules of Civil Procedure

and the Northern District of Illinois Local Rules. Any third party impacted by this Order

may move for appropriate relief.

9. The \$86,000.00 bond posted by E-ONE shall remain with the Court until a final

disposition of this case or until this Preliminary Injunction is terminated.
