## SEALED TEMPORARY RESTRAINING ORDER

Plaintiff Art Ask Agency filed an *Ex Parte* Motion for entry of a Temporary Restraining Order, seeking a Temporary Injunction, a Temporary Transfer of the Defendant Domain Names, a Temporary Asset Restraint, Expedited Discovery, and Service of Process by Email and/or Electronic Publication (the "Ex Parte Motion") against the defendants identified in Schedule A to the Complaint and attached hereto (collectively, the "Defendants") and using at least the domain names identified in Schedule A (the "Defendant Domain Names") and the online marketplace accounts identified in Schedule A (the "online Marketplace Accounts"). After reviewing the motion and the accompanying record, the Court hereby GRANTS Plaintiff's *Ex Parte* Motion as stated in this Order.

This Court finds, that it has personal jurisdiction over the Defendants because the Defendants directly target their business activities toward consumers in the United States, including Illinois, offering to sell and ship products into this Judicial District. Specifically, Plaintiff has provided a basis to conclude that Defendants may have reached out to do business

with Illinois residents by operating one or more commercial, interactive Internet Stores through which Illinois residents can purchase products bearing counterfeit versions of the Anne Stokes mark and of U.S. Copyright Registration Nos. VA 2-152-019 for Spell Weaver, VA 2-152-045 for Dark Hearts, VA 2-152-048 for Protector, VA 2-152-055 for Gothic Prayer, VA 2-152-057 for Blue Moon, VA 2-152-058 for Dragonkin, VA 2-152-061 for Spirit Guide, VA 2-152-063 for Kindred Spirits, VA 2-152-064 for Angel Rose, VA 2-152-065 for Summon the Reaper, VA 2-152-067 for Aracnafaria, VA 2-152-068 for Enchantment, VA 2-261-829 for Awake Your Magic, VA 2-272-364 for Rock God, VA 2-272-273 for Final Verdict, VA 2-272-075 for Dragons Lair, VA 2-272-041 for Pirate Skull, VA 2-271-652 for Gothic Guardian, VA 2-272-043for Unicorn Heart, VA 2-271-518 for Woodland Guardian, VA 2-271-514 for Glimpse of a Unicorn and VA 2-272-210 for Skull Embrace (the "ANNE STOKES Trademark and Copyrights").

This Court also finds that issuing this Order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate because Plaintiff has presented specific facts in the Declaration of Maria Strid and the Declaration of Michael A. Hierl and accompanying evidence clearly showing that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition. Specifically, in the absence of an *ex parte* Order, Defendants could and likely would modify registration data and content, change hosts, redirect traffic to other websites in their control, and move any assets from accounts in U.S.-based financial institutions, including Wish, Amazon and Alipay accounts, to offshore accounts. Proceedings against those who deliberately traffic in counterfeit merchandise may be ineffective if notice is given to the adverse party.

Accordingly, this Court orders that:

- 1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under or in active concert with them be temporarily enjoined and restrained from:
  - a. using Plaintiff's ANNE STOKES Trademark and Copyrights or any reproductions, counterfeit copies or colorable imitations thereof in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any products that are not genuine ANNE STOKES products or are not authorized by Plaintiff to be sold in connection with Plaintiff's ANNE STOKES Trademark and Copyrights;
  - b. passing off, inducing, or enabling others to sell or pass off any products as
    genuine ANNE STOKES products or any other products produced by Plaintiff,
    that are not Plaintiff's or are not produced under the authorization, control or
    supervision of Plaintiff and approved by Plaintiff for sale under Plaintiff's ANNE
    STOKES Trademark and Copyrights;
  - c. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control or supervision of Plaintiff, or are sponsored by, approved by, or otherwise connected with Plaintiff;
  - d. further infringing Plaintiff's ANNES STOKES Trademark and Copyrights and damaging Plaintiff's goodwill;
  - e. shipping, delivering, holding for sale, transferring or otherwise moving, storing distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Plaintiff, nor authorized by Plaintiff to be sold or offered for sale, and which bear any of Plaintiff's ANNE STOKES

- Trademark and Copyrights or any reproductions, counterfeit copies or colorable imitations thereof;
- f. using, liking to, transferring, selling, exercising control over, or otherwise owning the Online Marketplace Accounts, the Defendant Domain Names, or any other domain name or online marketplace account that is being used to sell or is the means by which Defendants could continue to sell Counterfeit ANNE STOKES products; and
- g. operating and/or hosting websites at the Defendant Domain Names and any other domain names registered or operated by Defendants that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product bearing Plaintiff's ANNE STOKES Trademark and Copyrights including artwork and any reproductions, counterfeit copies or colorable imitations thereof that are not genuine ANNE STOKES products or are not authorized by; Plaintiff to be sold in connection with Plaintiff's ANNE STOKES Trademark and Copyrights.
- 2. Each Defendant, within fourteen (14) days after receiving notice of this Order, shall serve upon Plaintiff a written report under oath providing: (a) their true name and physical address, (b) all websites and online marketplace accounts on any platform that they own and/or operate (c) their financial accounts, including all Wish, Amazon and Alipay accounts, and (d) the steps taken by each Defendant to comply with paragraph 1, a through g, above.
- 3. The domain name registries for the Defendant Domain Names, including, but not Limited to, VeriSign, Inc., Neustar, Inc., Afilias Limited, CentralNic, Nominet, and the Public Interest Registry, within five (5) business days of receipt of this Order or prior to expiration of this Order, whichever date shall occur first, shall, at Plaintiff's choosing:

- a. unlock and change the registrar of record for the Defendant Domain Names to a registrar of Plaintiff's selection until further ordered by this Court, and the domain name registrars shall take any steps necessary to transfer the Defendant Domain Names to a registrar of Plaintiff's selection until further ordered by this Court; or
- b. disable the Defendant Domain Names and make them inactive and untransferable until further ordered by this Court.
- 4. Those in privity with Defendants and with actual notice of this Order, including any online marketplaces such as iOffer, social media platforms, Facebook, YouTube, LinkedIn, Twitter, Internet search engines such as Google, Bing and Yahoo, web hosts for the Defendant Domain Names, and domain name registrars, shall within five (5) business days of receipt of this Order:
  - a. disable and cease providing services for any accounts through which Defendants engage in the sale of counterfeit and infringing goods using the ANNE STOKES Trademark and Copyrights, including any accounts associated with the Defendants listed in Schedule A;
  - b. disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using the ANNE STOKES Trademark and ANNE STOKES Copyrights; and take all steps necessary to prevent links to the Defendant Domain Names identified on Schedule A from displaying in search results, including, but not limited to, removing links to the Defendant Domain Names from any search index.

- 5. Defendants shall, within seven (7) days after receipt of such notice, provide to Plaintiff expedited discovery, including copies of all documents and records in their possession or control relating to:
  - a. The identities and locations of Defendants, their agents, servants, employees, attorneys, and any persons acting in concert or participation with them, including all known contact information;
  - b. The nature of Defendants' operations and all associated sales and financial information, including, without limitation, identifying information associated with the Online Marketplace Accounts, the Defendant Domain Names, and Defendants' financial accounts, as well as providing a full accounting of Defendants' sales and listing history related to their respective Online Marketplace Accounts and Defendant Domain Names;
  - c. Defendants' websites and/or any Online Marketplace Accounts;
  - d. The Defendant Domain Names or any domain name registered by Defendants;
     and
  - e. Any financial accounts owned or controlled by Defendants, including their agents, servants, employees, attorneys, and any persons acting in concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, Wish, Amazon and Alipay or other merchant accounts providers, payment providers, third party processors, and credit card associations (e.g., MaterCard and VISA).

- 6. The Court authorizes Plaintiff to serve third-party discovery on an expedited basis, with responses due not less than 10 days after service. The requests shall be proportional to the immediate needs of the case. *See* Fed. R. Civ. P. 26(b)(1). Plaintiff shall consider what documents it genuinely needs at this early stage, and shall take into account the burden on third parties. Plaintiff shall work cooperatively with third parties impacted by this Order and make reasonable, good faith efforts to ease the burdens imposed by Plaintiff's request for expedited discovery.
- 7. Defendants and any persons in active concert or participation with them who have actual notice of this Order shall be temporarily restrained and enjoined from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
- 8. Wish shall, within seven (7) days of receipt of this Order, for any Defendant or any of Defendants' Online Marketplace Accounts or websites:
  - a. Locate all accounts and funds connected to and related to Defendants,
     Defendants' Online Marketplace Accounts or Defendants' websites, including,
     but not limited to, any Wish accounts connected to and related to the information
     listed in Schedule A to the Complaint; and
  - Restrain and enjoin such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 9. Amazon shall, within seven (7) days of receipt of this Order, for any Defendant or any of Defendants' Online Marketplace Accounts or websites:
  - a. Locate all accounts and funds connected to and related to Defendants,
     Defendants' Online Marketplace Accounts or Defendants' websites, including,

- but not limited to, any Amazon accounts connected to and related to the information listed in Schedule A to the Complaint; and
- b. Restrain and enjoin such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 10. Alipay shall, within seven (7) days of receipt of this Order, for any Defendant or any of Defendants' Online Marketplace Accounts or websites:
  - a. Locate all accounts and funds connected to and related to Defendants,
     Defendants' Online Marketplace Accounts or Defendants' websites, including,
     but not limited to, any Alipay accounts connected to and related to the
     information listed in Schedule A to the Complaint; and
  - b. Restrain and enjoin such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 11. Any banks, savings and loan associations, payment processors, or other financial institutions, for any Defendant or and of Defendants' Online Marketplace Accounts or websites, shall within seven (7) days of receipt of this Order:
  - Locate all accounts and funds connected to Defendants, Defendants' Online
     Marketplace Accounts or Defendants' websites, including, but not limited to, any
     accounts connected to the information listed in Schedule A to the Complaint; and
  - b. Restrain and enjoin such accounts from receiving, transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.
- 12. Plaintiff may provide notice of these proceedings to Defendants, including notice of the preliminary injunction hearing and service of process pursuant to Fed. R. Civ. P. 4(f)(3), by electronically publishing a link to the Complaint, this Order and other relevant documents on a

website to which the Defendant Domain Names which are transferred to Plaintiff's control will redirect, and/or by sending an e-mail to the e-mail addresses identified in Schedule A to the complaint and any e-mail addresses provided for Defendants by third parties that includes a link to said website. The Clerk of the Court is directed to issue a single original summons in the name of "tianlizong Store and all other Defendants identified in the Complaint" that shall apply to all Defendants. The combination of providing notice via electronic publication and/or e-mail, along with any notice that Defendants receive from domain name registrars and payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.

- 13. Plaintiff's Complaint, Schedule A to the Complaint, Exhibit 2 to the Declaration of Maria Strid, and this Order shall remain sealed until Defendants' financial accounts are restrained. Plaintiff shall file unsealed versions of the Complaint, Schedule A to the Complaint, Exhibit 2 to the Declaration of Maria Strid, and this Order using the CM/ECF system prior to the expiration of this Order. Plaintiff shall deposit with the Court Ten Thousand Dollars (\$10,000.00), either cash, cashier's check or surety bond, as security, which amount was determined adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.
- 14. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order on two days' notice to Plaintiff or on shorter notice as set by this Court.

This Temporary Restraining Order without notice is entered on July 13, 2022, and shall remain in effect for fourteen (14) days.
